Sex, Lies and Electronic Delivery: E-reserves, Courseware & Copyright. Rosemary A. Chase, George Mason University

Copyright is one of those topics we all know we must face, but do so with trepidation. This presentation made sense of what can be a very confounding topic laying out the basis of the law and pending laws, interpretation of fair use, and the practical application of guidelines. Questions from participants at the end of the presentation helped clarify some issues libraries frequently encounter like "to digitize or not to digitize". (Only digitize things that are not already, i.e. don't print a digital document and then scan it.)

Marketing at Your Library. Jaime Stoops, Pamunkey Regional Library

This presentation provided a good look at the experiences of a public library in adapting "coffee shop" marketing strategies to the library setting. A good rule of thumb" successful strategies are customer driven, staff initiated, visually interesting, and ever changing. So let's get busy and be creative, engage patrons, get staff involved and promote the library!

Craig Koste Award Winners for 2007

In 1992, the Executive Council created the NYSLAA Award for Outstanding Service for New York State library assistants who are members of NYSLAA. Champion of Library Assistants – Goes into Transition

Many may not know the background of Eileen O'Hara in connections with Rochester Regional Library Council Library Assistants' Group and New York State Library Assistants Association.

Before I was affiliated with the library in 1990, Eileen had been an intricate part in advocating and developing a runway for library support staff. It was through her insight and passion that the RRLC group was started. At one time each library in the area, medical, academic, public, and special, sent a representative to the group, to network, plan programs, set standards and to boost the jobs that are preformed each day. She was a positive force with a quiet, calm way that mesmerized and guided staff to a more informed level. Her drive to learn and educate was unwavering. As a result of her involvement, I believe the Rochester Regional Library Council offers the most useful, up to date workshops and programs in the state. I know this because it is a topic of conversations with other library staff at the NYSLAA conferences I have attended.

Speaking of NYSLAA, Eileen was involved from the conception of this organization when it truly was NOT YET an organization. She felt strongly that library support staff needed to come together to discuss work problems, improve skills and have a sense of importance in the library work place. She worked with a group of dedicated people from various parts of the state who also shared her ideas and they developed an annual one day seminar that has grown and developed into a state organization which is respected throughout the country. Her service to NYSLAA included being a member of the Acting Council before the first officer elections, chairperson of the Conference Planning Committee, Recording Secretary, and an unwavering supporter and creative planner for the association. Due to her dedication, in 1992, Eileen was the first recipient of the now named Craig Koste Award for Outstanding Service that is presented annually at the NYSLAA Conference.

Eileen climbed the ladder as support staff as far as possible without her MLS. She felt she had more to give to the library world that she would not be able to achieve as a library assistant. Eileen made the decision to go back to school for her Master of Library Science degree to be better equipped to continue to meet her goals in spite of family needs and full time work pressures. This year she was the recipient of the 2007 SUNY Chancellor's Award for Excellence in Librarianship. This is what was written on the RRLC Webpage "Eileen, Head of Library Technology at SUNY Brockport, has made over twenty-two presentations at regional and statewide conferences and workshops, written or co-authored numerous professional publications, and most recently managed a major library management system conversion. She has been active in RRLC, SUNYLA and other library professional organizations for many years. The award is especially significant since it is the first Chancellor's Award for Librarianship to be awarded at Brockport in over a decade. The award will be officially presented in May 2007."

Now Eileen has made the decision to "transition" down the path to retirement. I believe we will see or hear from her in the future but for a while she will be satisfying her own desires instead of the daily routine in the library.

Call for Nominations

Nominations are now being accepted for NYSLAA Executive Council

Each year NYSLAA seeks nominations for three officers. Elections for President, Treasurer and Corresponding Secretary will be held this October. Descriptions of each officer's duties are listed below. All officers serve a two-year term and shall submit a written report to the President in January.

The **President** shall: 1) prepare an agenda for all general sessions and for meetings of the Executive Council; 2) preside at all general sessions of the Association and at meetings of the Executive Council; 3) fill the vacancies in the Executive Council by appointment; 4) authorize the creation of ad hoc and special committees; 5) act for the Executive Council between meetings of the Council; 6) collect written annual reports from all officers, committee chairs, the Ambassador, and the Certificate of Achievement Review Board Coordinator for publication in the first quarter newsletter; 7) perform other duties as may be required.

The **Treasurer** shall: 1) receive, record, hold, and disburse all monies of the Association at the direction of the Executive Council; 2) receive all membership dues; 3) prepare a written annual statement of accounts for the Association; 4) perform such other duties as may be required.

The **Corresponding Secretary** shall: 1) conduct such correspondence as may be directed by action of the Executive Council or Association and keep an official file of correspondence to be deposited in the archives upon completion of the term of office; 2) liaison the Public Relations Committee; 3) chair the Election Committee in even years; 4) perform such other duties as may be required.

Take an active role in your association! Consider running for office yourself, or nominate a colleague who you believe could make a significant contribution to our organization. (Nominees must accept the nomination in writing.) A nominating/acceptance form may be found on the following page. Please include a brief biography to be included with the ballot to acquaint voters with the candidate.
